1. Complete, sign and return the application within 60 days of the purchase date.
2. To qualify for a \$50 rebate, the toilet must have the WaterSense® label and use no more than 1.28 gallons per flush.
3. A copy of the sales receipt containing the purchase date, brand name, the model number, and pre-tax purchase price must accompany the application.
4. Your rebate will be applied as a credit to your **CWLP water bill** at the installation address. If the CWLP account is more than 30-days past due, CWLP reserves the right to withhold rebate amount until all past due amounts are paid.
5. Rebates are granted on a first-come, first-served basis until funds are depleted.
6. Limit 1 rebate per CWLP residential water account.

1. This rebate is available only for units purchased and installed on property that receives CWLP metered water service. New construction does not qualify; this program targets replacement of older less efficient toilets.
2. Should you own a condo or rental house, and the installation address is not the account to be credited, please call the Energy Services Office for approval.
3. The CWLP account servicing the installation address [or the account to be credited if it is different] - must be current. If the account has a past due balance of 30 days or more, the rebate will be held until the outstanding balance is current.
4. The rebate amount is \$50 and will be applied as a credit to the CWLP water bill. There is a limit of one rebate for each water account each CWLP fiscal year [begins every March 1st]. Please allow up to 45 days for processing this credit.
5. Rebates are granted on a first-come, first-served basis until funds are depleted each fiscal year. A completed application does not guarantee a rebate.
6. CWLP reserves the right to verify the installation of any HE toilet prior to the rebate being processed.
