CWLP Residential Electric Customers

INSTALL A HEAT PUMP AND QUALIFY FOR CWLP'S ELECTRIC HEAT RATE

***That's a 9% discount on CWLP's Regular Residential Electric Rate
from September 15 through May 14 of each year!***

CWLP residential customers who install heat pumps as their **primary*** heating source are eligible to receive the utility's Electric Heat Rate. *Even* if your heat pump is supplemented by a gas furnace. *Even* if you have a gas dryer, water heater, stove or other gas appliance. It's this simple: install a qualifying heat pump and you'll get a 9 percent discount on CWLP's Regular Residential Electric Rate during the months you heat your home. If your house is zoned for heating, a heat pump or other electric heating system must serve as the primary heat source for each zone.

WHAT A DEAL! Heat pumps provide year-round comfort and efficiency that can't be matched by *any* other heating system, and qualify you for substantially reduced electric rates during eight months of each year. As an added bonus, installing a heat pump can earn you a valuable **rebate** on your CWLP electric bill. If you install a qualifying heat pump **and are not already on CWLP's Electric Rates 34-37** (check the "Rate" column on your last CWLP bill), you can apply for the Electric Heat Rate by completing and returning the form below. Please make sure you provide **ALL** information. Incomplete applications will **not** be processed.

*CWLP will determine if a heat pump qualifies as "primary" using a formula that factors your home's square footage and the heat pump's capacity.
